Drip Irrigation and Mini Sprinkler Schemes in Rajasthan

Drip Plant

Objective

- To effectively increase the efficiency of irrigation water use from 25-40 percent to 90-95 percent through traditional irrigation methods and to increase quality production by its efficient use.

Subsidy

- 70 percent subsidy is payable to general farmers and 75 percent subsidy is payable to small marginal SC/ST/women farmers.
- All categories of farmers are payable subsidy on drip plant up to a maximum area of 5 hectares.

Eligibility

- The farmer should have at least 0.2 hectares of irrigated agricultural land.

Application Process

- E-Mitra/own computer can apply online on Rajkisan Portal.
- Farmer has the right to choose the supplier

Required documents

- Copy of Jamabandi (not older than 6 months), Aadhar Card/Janadhar Card, Irrigation Source Certificate, Soil and Water Test Report, Quotation of the supplier.

Other important points

- Purchase of the plant must be done from the registered manufacturer as per the standards prescribed by the department.
- If found correct in physical verification, the subsidy amount is transferred to the farmer or to the account of the supplier manufacturer/dealer with the consent of the farmer.

Validity

- Current financial year

Mini Sprinkler Plant

Objective

- To effectively increase the efficiency of irrigation water use from 25-40% to 70-75% through traditional irrigation methods and to increase quality production by its efficient use.

Subsidy

- 70% subsidy is payable to general farmers and 75% subsidy is payable to small marginal SC/ST/women farmers.
- Subsidy is payable up to a maximum area of 5 hectares.

Eligibility

- Farmers should have at least 0.2 hectares of irrigated cultivable land.

Application Process

- Online application on Rajkisan Portal can be done through e-mitra/own computer.

- Farmer has the right to select supplier.
- Required documents Jamabandi copy (not more than 6 months old), Aadhar card/Janadhar card, irrigation source certificate, soil and water testing report, supplier's quotation.

Other important points

- The plant must be purchased from the registered manufacturer as per the standards set by the department.
- If found correct in physical verification, the subsidy amount is transferred to the farmer or to the account of the supplier manufacturer / dealer with the consent of the farmer.

Validity

- Current financial year
